If there is any difficulty in submitting the return within the given time, a written request should be made to the undersigned specifying the circumstances for extension of time limit to avoid legal consequences.

5. If you come across any case of impersonation or of any person demanding illegal gratification or any favour either in cash or in kind, in connection with your submission of the return, you may furnish the details directly to the undersigned.
